

How to participate?

- Campaign duration: 9th October, 2023 at 12.00 a.m. UTC to 9th February 2024 till 11:59 p.m. UTC
- Participants (as defined below) can invest in any token(s) during the campaign duration.
- Participants (as defined below) need to trade a minimum volume of \$100 on their first trade (buy/sell) to qualify for the Reward (as defined below).
